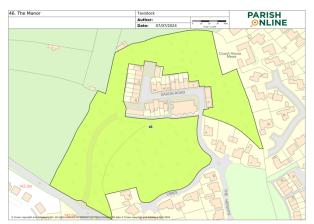

	This area is 2.57 Ha representing a good-sized green space serving the Manor Park housing development. The total parish area is 1,330 Ha.

This green space therefore retains the landscape of the historic house which it once surrounded.

	The dominant wildlife/landscape character of this site was developed from 1823 when the Manor House was built and grounds developed. This is therefore a mature landscape in which veteran trees are the most notable.

	The site contains a woodland and parkland with mature trees which help to provide cooling/shading in a neighbourhood of houses/tarmac. The woodland in particular (two thirds of the site) is of particular value in hydrological attenuation as woodland is one of the habitats of most value for storage and slowing the flow of water (see work within the community of the Westcountry Rivers Trust) .

	This site preserves a woodland and parkland landscape of a former historic house. It is predominantly an open recreational area of local community value. The site is used by local residents for purposes such as children's play (including ball games, cycling, free play) and for strolling and dog walking.	

Most of the site falls within land identified on the Nature Recovery Network and the site also possesses qualities of value in mitigation of climate change and its impacts.
